Whereas, the Town Board of the Town of Yorkshire, New York {the "Town") duly adopted a resolution directing MDA Consulting Engineers, PLLC, the Engineer for the Town, to supervise the preparat ion of a map, plan and report for providing the facilities, improvements or services in a portion of the Town, wherein a sewer district was established, as hereinafter described, and

Wherea s, after the said Town Engineer duly filed said map, plan and report in the office of the Town Clerk of the Town of Yorkshire, the said Town Board did on May 20, 2019, duly adopt an order reciting a description of the boundaries of the proposed dist rict, the maxi mum amount proposed to be expended for the improvement, the proposed met hod of financing to be employed, the fact that a plan, map and report describing the same are on file in the Town Clerk's office for public inspection and specifying that said Town Board shall meet at th,e Yorkshire Town Hall, located at 82 South Main St r eet, Delevan, New York, on the June JLO, 2019 at 7:00 PM for the purpose of conducting a public hearing on such pro posal to establish the sewer district with the specified improvements and to hear all persons int erest ed in the subject thereof concerning the same, and

Where as, copies of said order were duly published and posted according to law., and said Town Board did, at the time and place specified in said order, duly meet and consider such propo sa I and heard all persons interested in the subject t hereof, who appeare d at such time and place, concerning the same, and

Wherea s, the Yorkshire Town Board voted to establish the Yorkshire Corners sewer District on July 18, 2019; and

Whereas, the Town Board has called a Public Hear ing to be held on November 30, 2020 to increase the amount to be bonded to complete the project completed by the Map, Plan and Report to an amount not to exceed \$3.855 Million, as explained in the letter from MD.A, Consulting Engineers, PLLC, the Engineer for the Town, to Marcia Spencer, Town Supervisor, attached hereto as Exhibit 1 and expressly made a part hereof. The increase is necessary in light of the amount of grants received thus far and the uncertainty as to whet her any further grants will be awar ded.

Wherea s, the evidence offered at such time and place requires that the Town Board make the determination hereinafter made;

Now, Therefore, Be It Resolved, by the Town Board, in the County of Cattaraugus, that it be and hereby is determined as follows:

(1) The notice of hearing was published and posted as required by law and is otherwise sufficient.

- (2) That all of the property and property owners, within the proposed Sewer District are benefited thereby, even with the amount to be potentially bonded increase d.
- (3) That all of the property and property owners benefited are included within the proposed Sewer District, even with the amount to be potentially bonded increase d.
- (4) It is in the public interest to establish the proposed Sewer District as hereinafter described, even with the amount to be potentially bonded increased.

And be it, Further Resolved, that the Town Board does hereby approve the increase to \$3.55 Million as the maximum amount to be bonded in the Sewer District as hereinafter described known as Yorkshire Corners Sewer District, described as fo II ow s:



LOCAL LAW NO. 1 OF THE YEAR 2021

Amendment to the Town of Yorkshire. County of Cattaraugus. New York Zoning Law

BE IT HEREBY ENACTED BY THE TOWN BOARD OF THE TOWN OF YORKSHIRE, CATTARAUGUS COUNTY, NEW YORK, AS FOLLOWS:

SECTION 1. LEGISLATIVE INTENT

It is the intent of this legislation amend the Town of Yorkshire Zoning Law by requiring an 18 inches set back from all property lines for all fences.

SECTION 2. ADDITION OF SECTION 5.13.5 TO THE YORKSHIRE ZONING LAW

Set Back. All fences shall be set back 18 inches from all property lines.

SECTION 3. SEVERABILITY

The invalidity of any word, section, clause, paragraph, sentence, or provision of this Local Law shall not affect the validity and/ or constitutionality of any other part of this Local Law, which shall be given effect.

SECTION 4. EFFECTIVE DATE

This Local Law shall become effective January 13, 2021 subject to its filing with the New York Secretary of State.

CONFIDENTIALITY AGREEMENT

WHEREAS, the Town of Yorkshire (the "Employer") is a signatory to a collective bargaining agreement with Teamsters Local 264, affiliated with the International Brotherhood of Teamsters (the "CBA"); and

WHEREAS, the undersigned auditor, John F. Tierney, Jr. (the "Auditor"), is a field auditor for the New York State Teamsters Council Health and Hospital Fund (the "Fund"); and

WHEREAS, pursuant to the written notification of the Fund's audit of the Employer for the period January 2013 through December 2019 (the "audit period") and the terms of the Fund's Participation and Trust Agreements, the Fund is conducting an audit of the Employer to determine whether the Employer has made the proper contributions to the Fund for t he audit period (the "Audit"); and

WHEREAS, in the course of providing information to the Fund during the Audit, the Employer will be giving the Auditor access to confidential financial and other information, including the Employer's payroll records and certain other personnel records relating to any employees; and

WHEREAS, the Auditor has represented that his inquiries are for the sole purpose of determining whether the Employer has made the proper contributions to the Fund during the audit period.

NOW THEREFORE, the parties hereto agree as follows:

- The Employer will supply the Auditor with certain books and records in accordance with the Fund's Participation and Trust Agreements to the extent the Auditor reasonably deems necessary to determine whether the Employer has made the proper contributions to the Fund.
- 2. During the course of the Audit, the Auditor may prepare such necessary work papers to conclude the Audit and to complete an audit report to the Fund ("Audit Report"), but is not entitled to remove copies of the Employer's financial and other records from the premises. Notwithstanding the foregoing, and only to the extent the Auditor determines it is necessary to remove certain financial and other records from the Employer's premises in order to complete the Audit, the Fund agrees that the Auditor shall: (i) provide the Employer, in writing, a list of all such records by type, date range or other pertinent

information; (ii) upon request, discuss with the Employer whether one or more alternatives exists to removing such records; and (iii) if removal is deemed necessary by

the Auditor following such discussion, at the Fund's expense, photocopy such records, but only to the extent necessary to complet e an Audit Report to the Fund.

- 3. In the absence of a court order, the Fund agrees that none of its employees, officers or directors shall disclose any of the information contained in the financial and other records of the Employer. However, specific information relating to work performed within the Union's craft jurisdiction which is necessary for Auditor to complete the audit report may be provided to the Trustees of the Fund, legal counsel for the Fund, and Administrators of the Fund. In no event may the Auditor disclose to anyone, including the Trustees, legal counsel and Administrators of the Fund, any information that the Auditor reasonably determines is not relevant to the Employer's obligation to contribute to the Fund. Any work papers and photocopies of the Employer's records retained by the Fund shall be kept subject to the confidentiality provisions of this Agreement for so long as such papers and copies are retained.
- 4. The Fund acknowledges that the Employer's financial and other information constitutes a valuable, special, and unique asset of the Employer and agrees to use the financial and other information solely for purposes of the Audit and to disclose the financial or other information to the Trustees of the Fund, legal counsel for the Fund, and Administrators of the Fund only to the extent reasonably necessary and for the sole purpose of verifying the accuracy of work performed by and contributions due on behalf of the Union members. Such confidentiality shall be covered by the Auditor's professional standards.
- 5. The Fund agrees that it is legally responsible for any violation of applicable federal or state privacy and security laws regarding the information provided by the Employer.
- 6. This Agreement may be executed in two or more counterparts each of which shall be deemed an original, but all of which taken together shall constitute one and the same instrument.
- 7. This Agreement shall be governed by and construed and enforced in accordance with the laws of the State of New York without regard to conflict of laws principles thereof.
